GETTING STARTED

The City of Marshalltown is embarking on a process to update the Comprehensive Plan. A Comprehensive Plan is a long-range vision, guide and design for the community's future. Updating the Comprehensive Plan is an important step in determining how the City desires to guide land use, plan for necessary redevelopment, and maintain strong housing and economic base. In addition, this plan will update supporting system plans including transportation, infrastructure, parks/trails and public facilities. The Comprehensive plan will be conducted over five phases: (1) Initiation and Analysis (2) Visioning and Goals/Policy Setting (3) Alternatives (4) Draft Plan Preparation (5) Final Plan Preparation and Council review and approval.

An integral part of the Comprehensive Plan process is developing background information to understand where the City is today in terms of demographics, development and issue identification. To fully understand Marshalltown we also need to reach out to residents and business owners to recognize what they care about and what their vision is for Marshalltown. This process was conducted over public meetings held during October 4th-6th and are summarized below.

MARSHALLTOWN COMPREHENSIVE PLAN STEERING COMMITTEE HOLDS KICK-OFF MEETING

On October 4th the Comprehensive Plan Steering Committee held it first meeting. The committee heard a brief presentation from Stantec, the City's consultants, on the background report and what they can expect during the process to update the Comprehensive Plan.
